Pennsylvania's participation in methane mitigation for the oil and gas industry is growing steadily, as the state adds more companies and more employee locations year after year.



The total number of manufacturing and service companies in methane mitigation has grown 22.2% in the past three years, and Th 65% in the past 10 years. In 2024, bet Pennsylvania is home to 33 such companies, up from 27 in 2021, and 20 in 2014.



These locations stayed steady at 36 locations between 2014 and 2021 and then increased to 50 locations in 2024. Pittsburgh alone has 11 facilities, while Bridgeville, Charleroi, Canonsburg, and Philadelphia, each host at least two.



Several of the heaviest concentrations of methane mitigation locations nationwide are, not surprisingly, in the oil-and-gas-producing states. Pennsylvania, second only to Texas in natural gas production, remains among the top five states in methane mitigation employee locations:

As of 2024, Pennsylvania is host to 50 methane mitigation employee locations, accounting for 8.5% of the total for the top five states. As of 2024, these top states together represent 56% of U.S. methane mitigation employee locations (1,016 total). Texas alone, at 297 locations, currently accounts for nearly 30% of the U.S. total.

Pennsylvania's methane rules are likely encouraging growth in the state's methane mitigation industry.

Pennsylvania and two others within the top five states—California and Colorado—have state-level methane rules in place. Each has more methane mitigation employee locations than several top oil and gas-producing states without such rules, including Louisiana (35), Alaska (9), and North Dakota (26).

In the past three years, Pennsylvania has added a methane mitigation firm headquarters each year, indicating overall confidence in the state as a business environment for this industry. In 2021, five companies had their headquarters in the state. By 2024, eight companies were headquartered there.

Pennsylvania is headquarters to several well-established and fast-growing

firms. These include Morningstar, which over the past 30 years has sold 4 million off-grid solar units to oil and gas and other industries, and Advanced Cooling Technologies, selected by the *Central Penn Business Journal* as one of the fastest-growing companies in 2024.
